## Resolution 21-38

## A RESOLUTION ESTABLISHING WARD BOUNDARIES IN THE TOWN OF ST. CROIX FALLS

WHEREAS Wisconsin State Statute 5.15 requires all cities, villages, and towns with a population of one thousand (1,000) or more to establish municipal wards based on results of the 2020 census; and

WHEREAS the Polk County Board of Supervisors has adopted and transmitted to the Town of St. Croix Falls a tentative county supervisory district plan; and

WHEREAS the population for the Town of St. Croix Falls, Polk County, is at one thousand, one hundred, ninety three (1,164); and

WHEREAS due to the Polk County supervisory district plan the Town of St. Croix Falls, Polk County will be required to have three wards identified as ward one; ward two; and ward three; and

WHEREAS per Wisconsin State Statute 5.15(2)(d) ward 3 was created for county supervisor district #7; and

WHEREAS per Wisconsin State Statute 5.15(2)(b) wards 1 and 2 were created.

THEREFORE BE IT RESOLVED that the Town Board of the Town of St. Croix Falls, Polk County, does hereby adopt the wards described as follows:

Ward 1 – The portion of Town bordering to the North of the center line of 160<sup>th</sup> Avenue from State Road 87 east toward town boundary line; and the portion of Town West of State Road 87 to the town boundary line.

Ward 2 – The portion of the Town bordering to the South of the center line of  $160^{th}$  Avenue from State Road 87 east toward the town boundary line with the exclusion of the portion of Town located in the S  $\frac{1}{2}$  of SE  $\frac{1}{4}$  of Section 29; the portion of Town located in the S  $\frac{1}{2}$  of SW  $\frac{1}{4}$  if Section 28; the portion of Town located in NW  $\frac{1}{4}$  of NW  $\frac{1}{4}$  of Section 34; and the portion of Town South of the city boundary and West of the center line of Trap Rock Drive.

Ward 3 – The portion of Town South of the city boundary and West of the center line of Trap Rock Drive with the inclusion of the portion of Town located in the S  $\frac{1}{2}$  of SE  $\frac{1}{4}$  of Section 29; the portion of Town located in the S  $\frac{1}{2}$  of SW  $\frac{1}{4}$  if Section 28; and the portion of Town located in NW  $\frac{1}{4}$  of NW  $\frac{1}{4}$  of Section 34.

and;

BE IT FURTHER RESOLVED that Ward 1; Ward 2; and Ward 3 are hereby combined for voting purposes, so as to share the common polling place located at 1305 200<sup>th</sup> Street; and

BE IT FURTHER RESOLVED that the Town Clerk send a copy of the Resolution and map of Ward 1; Ward 2; and Ward 3 to the Polk County Clerk.


