REGULAR TOWN BOARD MEETING, December 21, 2022

The regular meeting of the Town Board of the Town of St. Croix Falls was called to order by Chairman Mike Dorsey at 6:00 p.m. on Wednesday, December 21, 2022, at the Town Hall. Proper notice was given as the agenda was posted at the town hall and on the town's website December 15, 2022. The Pledge of Allegiance was said. Present by roll call were chairman Mike Dorsey, supervisors Katie Appel, Will Bergmann, Jeremy Hall and Sharon Kelly. Also present were town clerk Janet Krueger and legal counsel Adam Jarchow. Others in attendance were Denise Evert, Mike Bratz, Anna Nelson, James Brost and Kristin Posson. Kelly/ Appel **moved** to approve the agenda; **motion carried**. Bergmann/Kelly **moved** to approve the minutes as printed for the November 16, 2022, November 18, 2022, and December 5, 2022, town board meeting and special town board meetings; **motion carried**.

No public comment was had.

Committee, Commission and Employee Reports: The treasurer's report was reviewed. Receipts for the period ending November 30, 2022, amounted to \$33,498.46, cash balance on November 30, 2022, was \$230,275.57. Ms. Krueger presented the clerks report. Kelly/Hall **moved** to adopt Resolution 22-46 amending the 2022 budget; **motion carried** on a unanimous roll-call vote, 5-0.

Resolution 22-46 A RESOLUTION TO AMEND THE 2022 BUDGET FOR THE TOWN OF ST. CROIX FALLS WHEREAS the Town's highway expenses will exceed the amount budgeted in 2022; and WHEREAS the Town of St. Croix Falls has funds available in the Town's General Operations Fund. THEREFORE BE IT RESOLVED by the Town Board of the Town of St. Croix Falls, Polk County, Wisconsin, that the sum of fifteen thousand dollars (\$15,000.00) is hereby transferred from the General Operations Fund to be designated to the Highway expense account.

Hall/Bergmann **moved** to approve payment of vouchers #22-297 through #22-330 amounting to \$24,610.70; **motion carried** on a unanimous roll-call vote, 5-0. The 2022 year to date budget summaries were reviewed. The permit logs were reviewed. There were no chairman or supervisor reports.

New Business: Discussion was had regarding a citizen complaint filed against a transient lodging rental located at 1918 140th Avenue. A public hearing will be held next month to amend or revoke the special exception for transient lodging at 1918 140th Avenue. Appel/Bergmann **moved** to adopt Resolution 22-47 approving additional operator licenses for the year ending June 30, 2023; **motion carried** on a unanimous roll-call vote, 5-0.
